TERMS & CONDITIONS

1. OBJECTIVE

To provide financial assistance to needy students in Bukit Timah Division.

2. ELIGIBILITY

- 2.1 This bursary is open to all residents in Bukit Timah Division. At least one of the parents and student must reside in Bukit Timah Division (in accordance to the information found on the Identity Card).
- 2.2 The student must be a Singaporean.
- 2.3 The student must or will be attending any of the following Independent/Government or Government-Aided Education Institutes:
 - Primary or Secondary School
 - Centralised Institute (CI)
 - Junior College (JC)
 - Polytechnic
 - Institute of Technical Education (ITE)
 - Autonomous University

N.B. Centralised Institute Year 3, Junior College Year 2 and Final Year Polytechnic/ Institute of Technical Education students are NOT eligible to apply.

2.4 Household income should not exceed \$6,000 or per capita household monthly income of \$1,000 and below.

4 APPLICATION PROCEDURES

- 4.3 The latest income statements or latest CPF Contribution Statement of parents and other members of the family staying in the registered household in Bukit Timah Division.
- 4.4 The latest school/polytechnic/ITE examination results or Primary 1 registration form/letter from the school to which the child is admitted.
- 4.5 All documents submitted with the application are not returnable.

5 PRIMARY 6 AND SECONDARY 4/5 STUDENTS

- 5.1 Primary 6 students in 2020 will be considered for provisional awards for Secondary School Category.
- 5.2 Secondary 4 (Express/Normal Technical)/ 5 (Normal Academic) students will be considered for provisional awards for CI/JC Year 1, Polytechnic and ITE respectively.
- 5.3 Evidence of acceptance of student to Secondary School, JC/Cl year 1, Polytechnic/ITE must also be produced for PSLE, GCE 'N'/'O' Levels students.

6 TERMINATION/WITHDRAWAL OF AWARDS

Awards may be withdrawn on the following grounds:

- 6.1 Poor and unsatisfactory academic performance and misconduct of the student during his/her term of award.
- 6.2 Any information given at the time of application is found to be false or incorrect.
- 6.3 The Committee reserves the right to terminate/withdraw the award if the student moves out of Bukit Timah Division on or before 31st December 2020.

7 DECISION OF THE COMMITTEE

- 7.1 The Committee will decide the award based primarily on the financial condition of the applicant. However, the academic performance and conduct of the applicant in school will also be considered.
- 7.2 The Committee does not need to give any reason for the approval/rejection of any award.
- 7.3 The decision of the Committee on any matters relating to the award is final and the Committee shall not entertain any enquiry.
- 7.4 The Committee reserves the right to amend any of these rules.

8 CLOSING DATE OF APPLICATION

- 8.1 Completed forms must be submitted to the BUKIT TIMAH COMMUNITY CLUB on or before 13 December 2020.
- 8.2 Alternatively, residents staying in Clementi can drop off their application forms in the letter boxes of Clementi Meadows RN, Gateway View RN or Ridges RC on or before **13 December 2020**.
